# **Implementation Strategy**

## Introduction

Long Beach Medical Center (LBMC) is a 462-bed, state-of-the-art regional medical center. Established as Seaside Hospital in 1907, it became known as Long Beach Memorial Hospital in 1958. The Medical Center is located on a 54-acre campus that it shares with Miller Children's & Women's Hospital Long Beach. These hospitals function under the same tax identification number but are separately licensed hospitals. The hospital mission is to improve the health and well-being of individuals, families and our communities.

As a regional medical center, Long Beach Medical Center provides health care through many specialties and services, including the Certified Comprehensive Stroke Center, Long Beach Adult and Pediatric Sleep Center, MemorialCare Breast Center, MemorialCare Heart & Vascular Institute, MemorialCare Imaging Center, MemorialCare Joint Replacement Center, MemorialCare Rehabilitation Institute, MemorialCare Todd Cancer Institute, Spine Health Center and Trauma Center.

In FY19, Long Beach Medical Center conducted a Community Health Needs Assessment (CHNA) to assess the significant health needs for the hospital service area. The CHNA and the resulting Implementation Strategy identify and address significant community health needs. These documents help guide the hospital's community health improvement programs and community benefit activities, as well as its collaborative efforts with organizations that share a mission to improve health. This Implementation Strategy explains how Long Beach Medical Center plans to address the significant health needs identified by the CHNA.

## **Report Adoption, Availability and Comments**

# **2019 Community Health Needs Assessment Summary**

Long Beach Medical Center conducted a Community Health Needs Assessment (CHNA) to comply with state and federal regulations guiding tax-exempt hospitals. The Community Health Needs Assessment incorporated demographic and health data for the communities served by the hospital. Significant health needs were identified from issues supported by primary and secondary data sources gathered for the CHNA. The needs were indicated by secondary data sources, focus groups and community

stakeholder interviews. Health indicators were considered significant health needs when they exceeded benchmark data, specifically county or state rates or Healthy People 2020 objectives. The significant health needs are listed here in priority order:

- 1. Housing and homelessness
- 2. Mental health
- 3. Economic insecurity
- 4. Public safety
- 5. Access to health care
- 6. Chronic diseases
- 7. Exercise, nutrition and weight
- 8. Food insecurity
- 9. Environment
- 10. Substance use and misuse
- 11. Pregnancy and birth outcomes
- 12. Preventive practices
- 13. Sexually transmitted infections
- 14. Oral health/dental care

Focus group participants were also asked to identify the most important significant health needs. The top five priorities were calculated by tallying all focus group participant votes and selecting the five significant health needs with the highest scores. The top priorities were:

- 1. Access to health care
- 2. Mental health and mental health conditions
- 3. Housing and homelessness
- 4. Public safety
- 5. Chronic diseases


# **Definition of the Community Service Area**

# **Significant Health Needs the Hospital Will Address**

This Implementation Strategy provides additional details on how Long Beach Medical Center plans to address the significant health needs identified in the 2019 CHNA. The hospital plans to build on previous CHNA efforts and existing initiatives, while also considering new strategies and efforts to improve health. The following criteria were used by the hospital's Community Benefit Oversight Committee and Strategy Committee to determine the significant health needs Long Beach Medical Center will address in the Implementation Strategy:

- Existing Infrastructure: There are programs, systems, staff and support resources in place to address the issue.
- Established Relationships: There are established relationships with community partners to address the issue.
- Ongoing Investment: Existing resources are committed to the issue. Staff time and financial resources for this issue are counted as part of our community benefit effort.
- Focus Area: Has acknowledged competencies and expertise to address the issue and the issue fits with the organizational mission.

As a result of the review of needs and application of the above criteria, Long Beach Medical Center will focus on: access to health care, chronic diseases, mental health, preventive practices, sexually transmitted infections and substance use and misuse. The hospital will consider the Social Determinants of Health (SDOH) as they address the identified priority needs. There may be ways to address SDOH items (housing, food insecurity, transportation, etc.), when implementing proven strategies to impact the priority needs of the community.

For each health need the hospital plans to address, the Implementation Strategy describes: actions the hospital intends to take, including programs and resources it plans to commit, anticipated impacts of these actions, and planned collaboration between the hospital and other organizations.

#### **Access to Care**

Long Beach Medical Center will address access to care by taking the following actions:

- Provide financial assistance through both free and discounted care for health care services, consistent with the hospital's financial assistance policy, for the uninsured and underinsured.
- Provide transportation support to increase access to health care services.
- Support Family Medicine primary care clinics.
- Provide grant funding and in-kind support to increase access to health care.

 Work in collaboration with community agencies to address the impact that the social determinants of health have on health care access.

## **Anticipated Impact**

Long Beach Medical Center will conduct these strategies with the overarching goal in mind to increase access to health care for the medically underserved.

Long Beach Medical Center anticipates the following impact from these efforts:

- Increase access to health care and reduce barriers to care.
- Provide financial assistance to qualified patients.
- Support access to health care services by providing transportation assistance.
- Increase awareness of the impact that social determinants of health have on access to health care services.

- Provide health education focused on activity, exercise and nutrition.
- Participate in health and wellness fairs and offer preventive screenings.
- Support persons with cancer and their caregivers with yoga, exercise classes, walking groups, education, counseling, peer mentoring, support groups and life coaches.
- Provide support groups to assist those with chronic diseases and their families.

- Provide public health education in the media and community health awareness events to encourage healthy behaviors and prevent chronic diseases.
- Provide funding and in-kind support to encourage chronic disease prevention and treatment.

## **Anticipated Impact**

Long Beach Medical Center will conduct the above referenced strategies with the overarching goal in mind to reduce the impact of chronic diseases on health and increase the focus on chronic disease prevention and treatment education.

- Improved coordination among health care providers and community resources and programs.

Long Beach Medical Center will monitor and evaluate the programs and activities outlined above. The hospital anticipates the actions taken to address significant health needs will improve health knowledge, behaviors, and status, increase access to care, and help support good health. The hospital is committed to monitoring key initiatives to assess impact and has implemented a system to track the implementation of the activities and documents the anticipated impact. Our reporting process includes the collection and documentation of tracking measures, such as the number of people reached/served and collaborative efforts to address health needs. Through our grants program, we track and report program outcomes. An evaluation of the impact of the hospital's actions to address these significant health needs will be reported in the next scheduled Community Health Needs Assessment.

# **Needs the Hospital Will Not Address**

Taking existing hospital and community resources into consideration, Long Beach Medical Center will not directly address the remaining health needs identified in the CHNA including: exercise/nutrition/weight, pregnancy and birth outcomes and oral health. Long Beach Medical Center has chosen to concentrate on those needs that can most effectively be addressed given the organization's areas of focus and expertise.
