

Important Information for Contracted Providers Regarding Referral Authorizations

Effective, February 1, 2014, our policy regarding services rendered without a referral authorization has changed. Claims submitted without a referral authorization will be denied. We will no longer review claims for unauthorized services that are submitted with an explanation regarding why the patient was seen without a referral authorization. All services need to be authorized in advance unless the services fall within the guidelines outlined below.

There will be instances where your office is unable to request a referral authorization in advance due to the emergent nature of the treatment. Services are emergent if waiting to get care could be dangerous to the patient's life or a part of his/her body. The emergent services are necessary to prevent damaging health effects.

If services were performed and fall within the guidelines mentioned, a referral request must be submitted within 48 hours of the date of service via our online provider portal, **MemorialCare Link** and include a call to the patient's Referral Coordinator located in their primary care physician's office. We have attached an updated Referral Coordinator Contact List for your reference.

The **MemorialCare Link** referral request needs to be marked with a priority status of "Emergency" and include a note with the date of service and the reason why prior authorization was unable to be obtained. This request is not a guarantee that the services will be retroactively authorized, as the services need to meet the guidelines listed above and patient needs to have eligible insurance at the time of service.

As a reminder, for routine services a referral request should be requested via **MemorialCare Link** a minimum of 5 business days in advance. Emergency (STAT) referrals should be requested within 24 hours of services being rendered and Urgent (ASAP) referrals should be requested within 48 hours of service.

Please note: Referrals should never reflect an Emergency or Urgent status solely for the benefit or convenience of the patient, the patient's family, or the provider's office.
